

Another Story is a narrative film that uses artifice in place of reality to tell an allegorical tale of the Holocaust through a Brothers Grimm-like fairy tale. The film communicates a formidable story, infusing fantasy, to provoke empathy and understanding without trivializing

history. Writer/ Director/Producer Lisa Wood Shapiro is a graduate of New York University's Film School at Tisch School of the Arts. Her film Another Story, nominated for a Student Academy



Award (Region III), as well as awarded New York University's First Run Film Festival Faculty Commendation, Best Production Management, Art Direction and Cinematography. It has also been screened at the Melbourne International Film Festival, and will be shown at the Jerusalem Cinematheque Film Series.
